GIVE APPRECIATED STOCK

You can maximize your giving and avoid paying capital gains taxes by donating appreciated stock. If you have long-term appreciated securities with unrealized gains (meaning they were purchased over a year ago and have a current value greater than their original cost) you can donate them to CAT and take a tax deduction for the full fair market value of the securities, up to 30% of your adjusted gross income.*
